- Disclaimer: Detention, demurrage, storage, and other shipping charges shall not be refunded by TFG
- All terms and conditions quoted apply to the transport of ISO-standard containers.
- These terms and conditions of sale are available in German and English. In case of doubt the German version shall prevail.
- Working days within the meaning of these terms and conditions of sale are Monday to Friday.
- Rates for transports from/to Italy on request.

Transport service

All transport products as offered by TFG are subject to the valid timetable at **www.transfracht.com**. The TFG transport service includes the following rail transport modes:

- combined transport (CT)
- combined transport / self-pick-up /self-delivery (C/S)

- The currently applicable prices are published in the price centre at www.transfracht.com. Prices are subject to operating feasibility and apply only as long as the current production concepts are maintained.
- All prices listed below are in euros (EUR).
- 30' containers are priced as for 40' containers. A surcharge applies to 45' containers.
- At seaports, for the loading points with a TFG rail link, pick-up/drop-off shall be "to wagon", otherwise "to chassis".
- Unless otherwise stated, all prices for road deliveries quoted in these terms and conditions of sale include any road tolls payable in the countries served, and in Switzerland prices include the performance-related heavy vehicle charge (LSVA) and a diesel surcharge, including CO₂ Tax.
- Uncleaned (tank) containers with a gross weight (including tare) of ≥ 5 tonnes will be treated as full containers and priced accordingly.

Trucking services

Road delivery of heavy containers

The container gross weight allowed on the road is generally limited to a maximum of 28 tonnes. Deliveries are possible only by prior arrangement with the relevant customer service office or TFG agency, with times of delivery / acceptance agreed.

The maximum container gross weight for cross-border traffic is 25 tonnes. The relevant road traffic regulations in the countries concerned apply.

Trucking - Free waiting time in road transport

Prices for combined transport include a free waiting time of two hours at the loading point(s), including customs clearance and weighing points. For pre-carriage and pick-up of containers from depots, no truck waiting time is recorded.

• Surcharge for each additional half hour:

If delivery of the container by TFG is later than stipulated, the waiting time shall be calculated from the beginning of loading. Events that are not caused by TFG are excluded (for example, possible delays at non-TFG depots and customs / weighing points). If delivery of the container by TFG is earlier than stipulated, the waiting time shall be calculated from the stipulated time or from the beginning of loading by the customer. If the customer begins loading before the stipulated time, the waiting time shall be calculated from the beginning of loading. If delivery of the container by TFG is at the stipulated time, the free waiting time shall be calculated from that time, regardless of when the customer begins loading.

TFG reserves the right to wait at the depot for a maximum of one hour due to reasons for which the customer is responsible (no notification of container's entry to the depot, no release and / or suitable container available for pick-up at the depot). Any extra costs incurred will be charged to the customer.

Transfers within German seaports

TFG Transfracht offers transfers by truck between the German seaports, as well as transfers within German seaports from or to a loading point that is not served by rail. The waiting time of the truck in the German Seaports is structured in the same way as in the inland. Other loading points are available on request. Terms and conditions of storage at the loading point can be provided on request. Handling at the rail terminal is included in the transfer costs.

Road deliveries without rail; hitching and unhitching

A surcharge shall apply for road deliveries without a link to rail transport and for cases in which, according to the customer's requirements, the container remains on the chassis with the tractor removed at the loading point or the vehicle with the container on is moved.

Prices apply per container and delivery <u>plus any national road tolls and diesel surcharges</u>.

Depending on the technical and organisational situation, the availability of the necessary equipment cannot always be guaranteed. Due to the limited availability, special equipment can be provided only upon due notification and confirmed time of use at least four business days in advance and upon confirmation of the responsible TFG agency. For tipper chassis, the waiting time regulation stated under Truck - Waiting time for road delivery applies. Deviating from this, we grant 30 minutes free waiting time for the use of side loaders.

NCTS-T1 shall be terminated by the customer no later than the specified day of presenting the goods again to customs.

Currency adjustment factor (CAF)

In response to discontinuation of the fixed exchange rate of the Swiss franc to the euro, TFG calculates a currency adjustment factor (CAF) on prices to compensate for the drop in the value of the Swiss franc. The CAF is applied on prices for CT and RST via Basel (with the exception of deliveries in Germany and France). The CAF rates are published in the price centre at www.transfracht.com.

Congestion Surcharge

Due to the current high utilisation of the port terminals, the congestion of the inland terminals and the associated irregularities in rail handling, a congestion surcharge has been introduced for transports from / to Hamburg, Bremerhaven, Antwerp and Rotterdam until further notice. The surcharge also applies to our Austrian inland terminals in Salzburg, Enns and Vienna, and to the northern ports: Hamburg, Bremerhaven and Wilhelmshaven. Additional ancillary charges

TFG reserves the right to calculate supplements and/or additional ancillary charges to compensate for increases in diesel price including CO2 Tax and energy price and for the costs of congestion at seaport and inland terminals. Prices quoted by TFG do not take into account the possible introduction of additional costs due to regulations and measures being imposed by local or national authorities. Should any such new costs be introduced, TFG reserves the right to levy the corresponding ancillary charges without delay.

Booking system and requirements

Information required

Bookings must be made via EDI or on **www.transfracht.com**. For bookings to be correctly accepted and executed, the following minimum details are required:

Freight payer, route, pick-up / drop-off depot for empty containers, loading/unloading point(s), net load weight, container length, height and type, shipping line, vessel, overseas port, dangerous goods or waste: full details, details of out-of-gauge cargo if applicable, preferred day of dispatch

Additional data for import bookings only:

Container number for loaded containers, customs clearance data

If a customs inspection (document or scan inspection) already exists for a container, this must be notified to TFG in advance during booking. In this case, customs handling / transport execution on the part of TFG is not possible. After successful inspection and release by customs, a corresponding transport can be carried out by TFG.

Orders are for loading empty containers from non-TFG depots <u>must</u> also be sent to the depot, which is responsible for checking the loading capacity.

In the case of public holidays that are not Germany-wide, the booking deadline will be moved up by one day for transport in the federal states that observe the public holiday.
