- Disclaimer: Detention, demurrage, storage and other shipping company fees will not be refunded by TFG.
- All terms and conditions apply to large containers of the ISO standard.
- The terms and conditions of sale are available in German and English. In case of doubt, the German version applies.
- For the purposes of these Terms and Conditions of Sale, working days are considered Monday to Friday.
- Conditions for transports from/to Italy on request.

Truck services

Road delivery of heavy containers

Road deliveries of heavy containers ≥ 28 t gross can only be carried out on request and by appointment with the responsible Customer Service / TFG agency.

In the case of cross-border transport, the weight of the container is limited to ≤ 25 t gross and the conditions for road traffic applicable in the respective countries apply.

Trucks – waiting time for road delivery

The CT grants a free waiting time of 2 hours at loading points, including customs clearance and weighing points. In the case of pre-collection / collection of containers in depots, no truck waiting time is recorded. Different regulation for side loaders, see page 9 Special equipment and different regulation for transshipments in German seaports, see page 4.

- each additional half hour or part thereof is subject to a surcharge: 60.00

If the container is provided by TFG at a later date than agreed, the time from the start of the loading process counts. Excluded are events for which TFG is not responsible (e.g. possible delays at customs / weighing stations). If the delivery by TFG takes place on an earlier date than agreed, the time from the beginning of the agreed time or the start of loading activity by the customer counts. If the customer starts charging before the agreed date of delivery, the time from the start of the loading process counts. If the vehicle is presented at the agreed time, the waiting time calculation begins regardless of the start of the customer's loading activity.

TFG reserves the right to wait at the depot for a maximum of one hour due to causes for which the Client is responsible (registration is not available at the time of delivery to the depot, exemption and/or suitable container are not available at the depot). Any costs will be invoiced to the client.

Transshipments in the German seaports

TFG Transfracht offers transshipments between the German seaports, as well as transshipments in the German seaports to and from one of the following loading points by truck. The free waiting time is 30 minutes, each additional half hour or part thereof is subject to a surcharge of 60 euros. For further regulations, see page 3. Other charging points not listed and conditions for parking are available on request. Handling at the respective rail terminals is included in the transit costs.

Weighing (SOLAS)

TFG Transfracht offers weighing for transports in combined transport within the framework of SOLAS regulations. The customer of the weighing service remains solely responsible for the fulfilment of the obligations under the SOLAS Directives.

The regulation on the free truck waiting time remains unchanged in the context of SOLAS weighing.

TFG Transfracht is not liable for costs and delays incurred in the course of the weighing process for additional operational processing (e.g. increased waiting times, new journeys) or consequential costs incurred as a result.

Pure road transport / uncoupling

A surcharge will be charged for pure road transports without corresponding rail transport, if the container remains on the chassis with the tractor unit deducted from the loading point (according to the customer's request) or if the vehicle including the container is removed.

The prices are per container and delivery plus tolls and diesel.

The starting point for the calculation is the respective terminal. In the case of pick-up / return at a depot, the distance to the assigned TFG handover / return terminal is taken as a basis. Cross-border road transport on request.

Truck shuttle

 Termination Shuttle: If the replacement is no longer possible or necessary, the last container is collected. The shuttle is thus considered complete. After completion of the provision order, only one unsaddle surcharge will be charged for all containers. If the individual containers remain longer than 24 hours on site, chassis rental will be charged.

Due to technical and organizational changes, the availability of the listed equipment cannot be guaranteed. Due to limited availability, deliveries can only be made with advance notice and appointment coordination with a lead time of at least four working days. For tipping chassis, the waiting time regulation specified under Truck - Waiting time for road delivery applies (see p.3).

For the use of side loaders, a free waiting time of 30 minutes applies.

- Note Austrian terminals: If containers are not delivered to the terminal on the day of departure of the train or are not accepted from the terminal on the day of arrival of the train, we charge handling in accordance with the applicable terminal conditions. If additional handling (e.g. customs inspection) is required, this will also be carried out in accordance with the applicable terminal conditions for a surcharge. The handling is shown in a separate invoice.

Interim parking at the hinterland terminal

At the terminals in the hinterland connected by TFG, interim parking can be carried out as part of the processing for containers in CT / KVS. In the event of overcrowding of the terminal parking area, the customer is obliged to stop further container inflow at TFG's request.

Customs Presentations (T1-NCTS)

If there is already an order for customs inspection (document or scan inspection) for a container, TFG must be informed of this in advance when booking. In this case, customs handling / transport execution by TFG is not possible. After inspection and approval by customs, a corresponding transport by TFG can be realized.
